1. Call PUBLIC HEARING TO ORDER: FY25 ANNUAL BUDGET: Read the Mission Statement, and Approve Agenda

2. PUBLIC HEARING - FY25 ANNUAL BUDGET (2024-2025) PRESENTATION.

Presentation of the FY25 Annual Budget: Superintendent Ryan and Business Manager/Board Secretary Allison Frost presented the board with the Proposed School Budget Summary for FY25. Mr. Ryan explained that there will be no tax increases for the fiscal year. The proposed rate is 10.96458%; however, if the proposed budget is authorized at the second public hearing on April 15th, the Department of Management could slightly change the tax rate. The proposed budget was calculated using a 2.5% SSA increase but the actual SSA amount has not been approved or released yet. Mr. Ryan explained that the district will still fall into the 101% guarantee as previously discussed.

3. Discussion of Proposed FY25 (2024-2025) Annual Budget.

Chairman Terrones asked the public and the board members if there were any questions or concerns with the proposed budget. No questions or concerns were voiced.
